

Shropdoc Guide To Prescribing In Adastra – Detailing Pharmacy in Rx

Purpose

- When prescribing remotely from home, the printed prescription comes out at Longbow
- It is useful and appropriate to detail the pharmacy to which the prescription must be sent
- This can be done in the Adastra notes but it is even better and removes a step if prescribers detail the pharmacy name on the actual prescription i.e. it saves Longbow having to search for the patient and open the notes to check
- The following slides show how to achieve this
